Announcements

Stacy Cepello has taken a new position in the Oroville Field Division on FERC license implementation efforts. Beverley Anderson-Abbs will temporarily serve as the TAC's Acting Vice Chair until the SRCAF Board replaces that position.

The Sacramento River Preservation Trust announced a celebration of the Trust's 22nd anniversary. They will be having a Members and Friends Picnic on Saturday, August 12, at Tehama County River Park at Woodson Bridge. Festivities will begin at 8AM and include a jet boat tour, a tour of nearby riparian habitat and related restoration sites, an interpretive hike, a catered BBQ lunch, displays, items for sale, and other low-impact activities.

Activity Reports

Roxanne Yonn, Manager, URS Corp. Public Affairs, is the consultant to DWR for the 2006 Emergency Levee Repairs Project. Roxanne gave a PowerPoint presentation and distributed a packet on the 29 identified critical erosion sites being repaired in Colusa, Sacramento, Solano, Sutter, Yolo and Yuba counties. Repairs are expected to be completed by November 2006 and cost approximately \$150 million. For more information email <u>leveerepair@water.ca.gov</u> or go to <u>www.levees.water.ca.gov</u>. Colusa Subreach Planning will be holding their 2nd Recreation Public Input Meeting tomorrow at 6:30PM, at Colusa Industrial Properties, to direct the development of two recreation plans for public properties in the Colusa Subreach. EDAW was chosen by the Advisory Workgroup to develop a master plan for the Colusa-Sacramento River State Recreation Area and a plan for public access and use of the 1200+ acres of public land in the Colusa Subreach. The City of Colusa has also filed for a new boat ramp - a project which has been requested to come before the TAC for review. Integration of the boat ramp with camping, hiking trails, mitigation for campground expansion, and other activities will be included in the conceptual plan for discussion at tomorrow's meeting. Interim results are expected in the fall. The final master plan will be used by State Parks and the local community as a guide for detailed planning. The next Public Input Meeting will be scheduled for October.

Family Water Alliance (FWA) received funding from Wildlife Conservation Board (WCB) for a cooperative project between FWA and Reclamation Districts 307/999 to construct a retrievable, self-cleaning fish screen at the Sacramento River water intake one mile north of Clarksburg within Yolo County. The proposed project is consistent with the Central Valley Project Improvement Act (CVPIA) Anadromous Fish Screen Program. The project, from Proposition 40 funds being administered by the WCB, is proposed to benefit threatened and endangered fish species by screening a 42" district water intake siphon carrying 70-100 cfs. The diverted water supplies both of

these Reclamation Districts, including 33 farms on approximately 25,000 farmable acres. Total cost for this project is approximately \$636,784 with contributions from WCB, CVPIA and Reclamation Districts.

<u>Current Projects/Updates</u>

<u>Hamilton City (RM199)</u> – The flood control project and habitat restoration has been combined and will upgrade the level of protection for Hamilton City and farmers in the area. Authorization of the project is in both the House and Senate versions of WRDA, and is anticipated to be passed this fall. Funding is in the core budget for engineering and development; funding is in this year's budget for surveys and core borings. Contacts and communications with local landowners are being done now through SRCAF. Swainson Hawk and VELB surveys have been completed and foundation borings will be started by mid-August. Soil sampling will take place where restoration is planned. There will be an assessment for maintenance of a new levee. The estimated cost for the project is \$60 million. Construction is targeted for 2008. A workgroup meeting is targeted for September.

New Projects or Proposal Review

<u>Shasta Ranch Mining and Reclamation Plan Project (RM 279)</u> – is a request for approval for a Use Permit and Reclamation Plan to mine alluvial sand and gravel near the Sacramento River (2.5 miles SE of Anderson) in Shasta County. The project site encompasses 947 acres, of which 268 acres will be mined for aggregate material.
