Meeting Notes

Glenn Hawes moved, seconded by Lynnel Pollock, to approve the December 13, 2017 meeting notes. Motion carried.

2. Presentation of information of the Safe Harbor Program and the Cooperative Agreement with Davis Home Ranches Jane reviewed the history of the Programmatic Safe Harbor Agreement and briefly about Davis Home Ranches entering into the Agreement. She then introduced speakers John Brennan and Emily James, both from Davis Ranches who are hosting today's Forum board meeting.

3. Presentation of information of Davis Home Ranches – John Brennan and Emily James

A PowerPoint presentation was given providing information about the Davis Ranches in Colusa County. The ranches have been owned by the same family since 1857 and include 8,500 acres. It was historically a wheat and rice farm. Patriarch Howell Davis was the founder of the town of Sycamore, CA, which included 900 people living on a portion of the current ranch site. The bricks for construction of the historic Davis home were made on site; construction was completed in 1894. There are currently 30 family members who share ownership of the ranch, and whose goal is not only to restore the home, but to restore 100 acres by the year 2100. The owners work with tenants and conservation partners to integrate sustainable farming and native habitat into the working agricultural landscape. They are also committed to preservation of migratory birds, waterfowl and wildlife habitat. The ranch continues to farm, save water, reduce waste, recycle, educate and make improvements.

Money from establishing a hunting club has provided cost share for restoration. Davis Ranches worked with Rob Irwin extensively to develop both the baseline and the conservation management plan for restoration under the Safe Harbor Agreement, covering the Valley Elderberry Longhorn Beetle and the Giant Garter Snake. They are also working to provide for Swainson's Hawk and Monarch butterflies, among other species. There are currently more than 40 acres of restored habitat. The ranch is interested in working with their neighbors who are able to establish species baselines and able to have the same protections regarding take. Another goal is planting habitat hedgerows from the Sacramento River to the Colusa National Wildlife Refuge.

As noted at the last Forum board meeting, Davis Ranches has a habitat exchange program and are the pilot project on how to build mitigation. They keep working on adding different species. Also, the Regional Conservation Investment Strategies (RCIS) Program, administered by CDFW's Habitat Conservation Planning Branch in Sacramento, encourages a voluntary, non-regulatory regional planning process for conservation and habitat for species.

After the presentation(s), Emily James gave a tour of the ranch house, which is complete with period pieces, including a Steinway piano, stained glass windows, dumb waiter and a grand entrance. Descriptive labels accompany many item throughout the house. John Brennan then lead a car caravan tour of the ranch, including several stops along the way to see their solar arrays, new planting on restoration sites and to watch the migratory birds on the property.
