## Service Announces Availability of a Draft Environmental Impact Statement/Environmental Impact Report for the Llano Seco Riparian Sanctuary Unit Restoration and Pumping Plant/Fish Screen Facility Protection Plant Project

## Comments will be accepted until June 25, 2012

The U.S. Fish and Wildlife Service today announced the availability of a draft environmental impact statement and environmental impact report (EIS/EIR) for the Llano Seco Riparian Sanctuary Unit Restoration and Pumping Plant/Fish Screen Facility Protection Project. This project is located in Glenn and Butte Counties, California.

The Service and the California Department of Fish and Game (CDFG) are the federal and state lead agencies for the proposed project. The proposed project includes riparian restoration on the Riparian Sanctuary Unit of the Sacramento River National Wildlife Refuge and protection of the Princeton-Cordora-Glenn and Provident Irrigation Districts pumping plant and fish screen facility.

The notice will publish in the Federal Register on May 4, 2012. The public comment period begins May 4, 2012 and closes on June 25, 2012.
